- Former students who have been **academically disqualified** cannot be readmitted to Fort Lewis College without the submission and approval of this form. For these students, the form must be submitted by the appropriate **admission deadline**.
- **All other petitions are due to the Registrar's Office by Census Day of the student's first term back at Fort Lewis College.**

Academic Renewal Policy:

A returning Fort Lewis College student who has not attended Fort Lewis College for at least six consecutive terms (e.g., Spring, Summer, Fall, Spring, Summer, Fall) and whose Fort Lewis College cumulative GPA is below 2.00 may apply for Academic Renewal. If Academic Renewal is approved, grade point averages for work completed prior to readmission will not be carried forward. Previously completed courses with an earned grade of C - or higher are eligible to count towards graduation if they are allowable under the Time Limits on Coursework policy.

Students apply for academic renewal as part of the readmission process. Questions about Academic Renewal process should be directed to the Registrar's Office (academicstanding@fortlewis.edu). Questions about admissibility should be directed the Office of Admission (admission@fortlewis.edu).

A student may receive academic renewal only once.

All coursework completed prior to the renewal will remain visible on the student's academic record. If renewal is granted, the student's permanent record will denote "ACADEMIC RENEWAL APPROVED" with the date.

Academic Renewal applies only to actions taken by Fort Lewis College. Other colleges may or may not accept the action of the Academic Renewal.

Students granted academic renewal must meet all established College policies for satisfactory academic standing. Students who receive academic renewal will be required to complete at least 30 hours of credit after readmission before they are eligible for a baccalaureate degree, even if all other degree requirements have been met.

I understand that if Academic Renewal is approved, previously completed courses with an earned grade of C - or higher will count towards graduation if they are allowable under the Time Limits on Coursework policy. (Previously completed courses with an earned grade below C- will not count towards graduation.)

I understand that I may receive academic renewal only once.

I understand that Academic Renewal does not apply to the Financial Aid Satisfactory Academic Progress Policy. If you are planning to apply for financial aid it is critical for you to meet with a financial aid counselor to review how academic renewal impacts financial aid.

I have been counseled about the implications of academic renewal.

Warning: If you have taken courses elsewhere since last attending Fort Lewis College, you must meet Fort Lewis College admission standards.
