- Any official college transcripts, if you have not supplied all your official transcripts to the Admission Office already. These must be received by that office before this appeal form can be reviewed;
- An appeal letter, if you did not earn any credits, describing in detail the circumstance(s) involved that prevented you from earning any credit during the term(s) you received Federal Pell Grant and/or student Direct Loan funds;
- Supporting documentation (examples: medical records/statements, police reports, copy of death certificate/obituary, etc.) related to the reasons outlined in your letter (if applicable).

I certify that the information submitted on and with this form is accurate and complete. By signing below, I acknowledge that if my appeal is denied I will not be eligible for any Federal, State, or institutional need-based aid until I have successfully completed at least twelve (12) credits at Fort Lewis College without benefit of Federal financial aid.
